TO: All Little Creek Alumni

Dear Alumnus,

I hope this letter finds you and yours of good courage and in health.

I am certain that most of you have heard of the possible relocation of Little Creek Academy. As you are probably aware, the environment has changed in the Little Creek area, especially in the last five years. These changes have begun to cause an increasing number of challenges regarding school operation. Because of these changes, the Little Creek Academy Board voted in December of 1992 that the school should relocate. The next month, January 1993, The Layman's Foundation also voted that it was in the best interest of Little Creek Academy to relocate.

The above board votes culminated in the sale of 289 acres on Thursday, February 24, 1994. I must admit that I look upon this sale with mixed feelings. I feel bad that the farm has been sold; however, anytime change occurs, often times pain is part of the process. This sale means that seven dwellings will be lost due to the sale of the farm. We have use of these dwellings and farm land for six months.

Forty-five acres, which is the immediate campus area, has been retained. The nursing home will continue to operate as it is, and other buildings could be leased by different entities, etc. There are negotiations ongoing regarding this.

I embark on this new school project with fear and trembling. This is where you come in. I am asking each of you to especially remember to our Father in Heaven the direction and needs of this school. I am inviting you to share any ideas, suggestions, and/or helpful hints which could be useful to the future of this institution.

The Layman's Foundation is planning to purchase approximately 1,200 acres about fourteen miles northwest of Crossville, Tennessee. This property has 700 acres of beautiful farm land which is being farmed at present, and approximately 500 acres of woods. The property has one large stream and one large creek. It also has two natural gas wells. If you will look on your map where Fentress, Overton, and Putnam Counties all come together, you will be in the approximate center of this farm. There is a 4,000-foot frontage on Highway 62, approximately halfway between Monterey and Clarkrange. This property should "close" approximately March 21, 1994.

We hope to build approximately twenty staff homes, a church, an administration building/cafeteria complex, two dormitories, a multi-purpose auditorium complex (which

includes the music departments, the art/ceramics, and the woodworking areas), a shop, a pole barn, and other buildings as The Layman's Foundation determines.

Our plan is to have at present, at least six industries:

- a. Colporteur ministry. Two vans, with approximately twenty students involved each day.
- b. A large grain farm, which would involve wheat, corn, soybeans. etc.
- c. Green beans involving contracts
- d. A truck farm, which would include ten 30' x 150' cold frames for winter crops, also orchard, berries, vegetables, etc. All will be irrigated by a dam which we hope, someday, will power a grist mill.
- e. Greenhouses. To begin with, we will have ten 30' x 125' hot houses. We hope to add ten more greenhouses the following year.
- f. Bakery. Our goal is to grow approximately 250 acres of winter wheat and bake it out.

We hope to begin a small medical work as God leads.

We have lined up new staff with expertise in the above areas, except for the grain and bean farming. Please pray that we make the right decisions regarding staff which will be involved in the above industries.

This year we have one van going out daily in a colporteur ministry, and it is going very, very well. Praise the Lord for such wonderful young people.

I have tried in this letter to answer a few possible questions. This letter may, in fact, have caused you many more questions. I welcome any communication from any past student. I would again ask for your prayers in relation to the future of this school. My motivation for my part in the above scenario has been only for the ultimate good of these young people, and to carry out in the best way possible the philosophies that Prof Straw founded this school on so many years ago.

For future communication sake, I am enclosing a questionnaire which should be selfexplanatory along with a stamped, self-addressed envelope.

Thank you for your time in reading this letter, and I'm looking forward to future communications.

May we have faith to follow God's leading, to trust our futures to Him, and to be at peace with Him and with one another.
