

CONSTITUTION AND BYLAWS OF LITTLE CREEK ACADEMY ALUMNI ASSOCIATION

Preamble

We, the members of Little Creek Academy Alumni Association, are united by the common bond of being graduates, attendees, faculty and /or workers of Little Creek Sanitarium, Hospital and School, which will be referred to as Little Creek Academy. We wish to respect the heritage and foster the memory of the institution by forming an association to continue that memory, sustain friendships, and promote social interaction among said members and current employees of Little Creek Sanitarium.

Article I <u>Name</u>

The name of this association shall be Little Creek Academy Alumni Association.

Article II **Purpose**

The purpose of this association shall be four-fold:

- 1. To sustain the self-supporting principles in the philosophy of the members as envisioned by the founders of Little Creek School and Sanitarium.
- 2. To foster a continuing development of spirituality, loyalty, and fellowship among the members, other graduates, former staff, and active workers of Little Creek School and Sanitarium.

To compile and maintain a history of Little Creek School and Sanitarium.

To keep the members, other graduates, and staff in touch with each other and recognize their distinguished service anywhere in any field.

Article III Membership

Membership in the association is defined by the following:

- Graduate those who have received a diploma from Little Creek Academy.
- 2. Non/Graduate those who attended Little Creek Academy for at least one year.

3. Associate - those who served on the staff or board of Little Creek.

Honorary - those who have been elected to membership by the association for outstanding support and contribution.

Active - those who have paid their annual dues.

Voting - will take place at the annual association meeting.

Office Holding - limited to Graduates.

Article IV

<u>Dues</u>

Annual dues shall be determined by the association in business session. The funds shall be used for the operation expenses of the association, cost of annual functions and called special business meetings, and any special projects adopted by the association in business session as funds allow. Student alumni pay only ½ dues.

Article V

Election and Term of Officers

Officers for the association shall consist of president, president-elect, and secretary-treasurer governed by the following criteria with no term limits:

- 1. Eligibility Graduate members as recommended by a nomination committee named at the previous annual association business meeting.
- 2. Committee an executive committee shall be defined by the following members: association president, association president-elect, association secretary-treasurer, president of Little Creek, and administrator of Little Creek Sanitarium. This committee shall have the power to interpret the constitution and rule on all matters of policy.
- 3. Election association members shall elect officers for a two-year term by a majority affirmative vote during an official annual business session. Elected officers may resign at will with notice.

Article VI **Duties of Officers**

The following duties shall be required for each officer of the association:

- 1 President to preside at all meetings of the association and the executive committee, and oversee the progress of the association.
- 2. President-elect to assist the president in his duties and to preside when the president is absent or at his request.
- 3. Secretary-Treasurer to attend and keep permanent records of all meetings, prepare minutes and newsletters, and keep financial records.

Article VII

Association Meetings

The association shall organize an alumni weekend and official business session the first weekend in November each fall, with the cooperation of the Administration of Little Creek Sanitarium, and will be held on the Little Creek Campus. A notice of the meeting shall be mailed to each member at least two months prior to the planned weekend.

The secretary-treasurer shall submit an annual financial report and the minutes of the previous year's official business meeting at the annual business meeting.

Parliamentary procedures shall be respected by all involved in official business sessions, with the current association president or his designee presiding. A quorum shall consist of all eligible members present at official business sessions.

Article VIII

Safe Guards and General Liability

To ensure fiscal responsibility, all checks of the association shall be signed by the secretary-treasure, or the administrative office of Little Creek Sanitarium. No officer of the association or other person shall be authorized to render checks payable to him or her. All notes, bonds, or other promises to pay money shall be signed by each member of the Executive Committee.

No officer, committee member, member of the association, or other persons shall contract or incur any debt on behalf of the association or in any way render it liable unless authorized by the Executive Committee. Nor shall they be authorized to promise in behalf of the association moral or financial support or aid to any other charitable organization without the approval by vote of associations members in official session.

No member of the association, officer or otherwise, shall be personally liable for any act of the association, its Executive Committee members, or officers.

Article IX

Amendments and Changes

Bylaws may be replaced or amended by majority vote of association members.
